**ORDER DIRECTING THE D.H.S.M.V. TO REVOKE, SUSPEND, OR WITHHOLD THE  
ISSUANCE OF A DRIVER'S LICENSE**

The court hereby directs D.H.S.M.V. to revoke, suspend, or withhold the issuance of a driver's license to:

1. The period of suspension, revocation, or withholding of issuance is:

2. The basis of the suspension, revocation, or withholding of issuance is a violation of one of the following:

\_\_\_ Unlawful misrepresentation or misstatement of age for the purpose of purchasing alcoholic beverages (Fla. Stat. 322.056 and 561.22).

\_\_\_ Unlawful possession of alcohol by a minor under the age of 21 (Fla. Stat. 322.0056 and 562.111).

\_\_\_ Delinquent act involving the possession or use of a firearm (Fla. Stat. 790.22(5) and (10)).

\_\_\_ Criminal Mischief (graffiti), in violation of Fla. Stat. 806.13(5).

The Child may elect to reduce the period of suspension, revocation, or withholding of issuance by clearing graffiti from public property at the rate of 1 day for each hour of service performed.

- \_\_\_ Violation involving the sale, delivery, possession and manufacture of a controlled substance or paraphernalia (Fla. Stat. 322.056 and 893 et seq.).
- \_\_\_ Theft of a motor vehicle, parts, or components of a motor vehicle (Fla. Stat. 322.274 and 812.014). The period of suspension is for the entire term of the sentence imposed.
- \_\_\_ Unlawful failure to pay an establishment for gasoline when dispensed into the fuel tank of a motor vehicle (Fla. Stat. 812.014(5)).

3. The Court:

- \_\_\_ Objects to D.H.S.M.V. issuing a “business purposes only” permit.
- \_\_\_ Does not object to D.H.S.M.V. issuing a “business purposes only” license. This means that the Child can drive to and from school, or to and from a court-approved place of employment.
