**ORDER FOR SPECIAL CONDITION OF PROBATION  
PROHIBITING RETURN TO PROSTITUTION MAPPING ZONE**

It is hereby ordered and adjudged that, as a special condition of probation, the Defendant shall not return to the below designated area, identified as the "Prostitution Mapping Zone," during the period the Defendant is on probation pursuant to this sentence, except when traveling through said area in a motor vehicle.

The Prostitution Mapping Zone is a section of Orange County, Florida approximately 4 blocks wide, made up of approximately 2 blocks on either side of the South Orange Blossom Trail, from Holden north to Colonial Dr., and 2 blocks on either side of Colonial Drive east from its intersection with the South Orange Blossom Trail to Mills Avenue which area is more specifically defined below.

The Prostitution Mapping Zone includes all streets and properties between or within the area bounded by the below named boundaries and boundary roadways, all properties adjoining the named boundary roadways, as well as the boundary roadways.

The exact boundaries and boundary roadways of the Prostitution Mapping Zone are as follows: Beginning in Orange County, Florida at the southwest corner of the intersecting of Rio Grande Avenue and Holden Avenue, north on Rio Grande Avenue to Rock Lake. North along the east shore of Rock Lake to Rio Grande Avenue and then north on Rio Grande Avenue to Colonial Drive. East on Colonial Drive to State Road 441 (commonly known as Orange Blossom Trail). North on State Road 441 to Atkins Place. East on Atkins Place to Westmoreland Drive. North on Westmoreland Drive to Alameda Street. East on Alameda Street to Lake Concord. East along the south shore of lake Concord to Interstate 4 and then north to Marks street. East on Marks Street to Mills Avenue. South on Mills Avenue to Concord Street. West on Concord Street to Westmoreland Avenue. South on Westmoreland Avenue to 37<sup>th</sup> Street. South along the west shore of Lake Holden to Raymer Road. South on Raymer Road to Holden Avenue. West on Holden Avenue to the point of beginning at Rio Grande Avenue.
